Following the submission of the Building Bridges Initiative (Constitutional Amendment) Bill, 2020 by the Independent Electoral and Boundaries Commission (IEBC) vide letter reference **IEBC/VREO/2/12/BBI** dated 26th January, 2021, the Bill was tabled on 09th February, 2021 in the County Assembly and committed to the Justice, Legal and Delegated County Legislation Committee.

The Committee will be conducting public participation on the BBI (Constitutional Amendment) Bill, 2020 in fulfillment of the requirements of Article 196 of the Constitution.
