## **COMMUNICATION FROM THE CHAIR**

**The Speaker {Hon Edin wario}:** Honourable members, I have received the following communication. On the 25<sup>TH</sup> of September 2022, I got from the County Government of Marsabit, Office of the Governor, a letter. The letter reads; The Honourable Speaker, County Assembly of Marsabit, Reference, Selection Panel pursuant to Article 201 (d) of the Constitution, Section 58, Section 58(a) and Section 44, Section 44(2)(a), 2(b), 2(c) and 2(d) of the County Government Act;

The above matter refers; Honourable Speaker, kindly note that the position of the Secretary to the County Public Service Board is vacant and requires to be substantively filled to ensure the proper functioning of the County Public Service Board. The County Public Service Board plays a critical role in constituting the personnel to serve the people of Marsabit as prescribed below.

Further, it is of paramount importance that this process of properly constituting the County Public Service Board as a shared responsibility of the County Executive and the County Assembly is carried out seamlessly in compliance with the law. Our collective oath to the office demands that both arms of Marsabit County Government work towards efficient and effective service towards the people of Marsabit.

Section 58(1)(c) as read with section 58(a) of the County Government Act 2012 provides that the Governor shall nominate and with the approval of the County Assembly appoint members to a selection panel for the purpose of selecting suitable candidates for appointment of members to the County Public Service Board. Accordingly, and in fulfillment of my duties, I nominate the following persons as members of the selection panel in line with section 58(a)(2) of County Government Act 2012.

- 1. Joseph Guyo Halake- Chairman.
- 2. Hawo Guyo Shibia- Private Sector.
- 3. Abdulatif Mohamed Jarso- LSK.
- 4. Ahatho Guyo Umuro- CPA.
- 5. Bursuna Ejere- Workers.

The panel herein meets the two third rules in its composition as such. The names of the nominees together with their curriculum vitae and supporting documents are followed herewith for your consideration and approval. Be that as it may, reference is made to Article 201(d) of the constitution that underscores the prudent use of public resource. Therefore in light of the above, and as permissible by section 44(2)(c) of the County Government Act, I reserve the right to use this same selection panel, if need be in performance of my duties as contained in section 44 of the County Government Act. Your expeditious action on this matter will

In consideration of the above information, cited laws and County Assembly Standing Orders, your office should be in a position to determine the leadership of County Assembly. In the Chief Magistrate of Kenya of Marsabit, election petition number E001 of 2022, between **Golich Sadia Galma** petitioner, vs. **Independent Electoral and Boundaries Commission** first respondent, **United Democratic Party Alliance** second respondent, **the Clerk of County Assembly of Marsabit** third respondent, **Araru Sadia Osman** fourth respondent. Upon preliminary objection dated 26th September 2022 by the third respondent and fourth respondent coming up for hearing on 26th September 2022 and upon hearing the arguments for preliminary objection by counsel for the first and the third and the fourth against the petition by the counsel for petitioner, it is hereby ordered that the preliminary objection dated 26th by third respondent is allowed for the reason that the honorable court lacks requisite jurisdiction to hear and determine the election petition as it is not designated as an election court.

That the orders dated 19th September issued in prayer two of application dated 16th September instructing the first, third respondent from facilitating swearing in of the fourth respondent as **a member of County Assembly Marsabit County** is vacated. Issued under my hand and seal, honorable court on 27th, honorable **Christine Wekesa principal magistrate**, **Marsabit Law Court. Final notice**, this is a valid court order and any person who disobeys it shall be guilty of contempt of court and hence liable for imprisonment upon a period of 6 months.

Order, I have pursued and considered the notice of motion dated on 28th September, 2022 the same is certified urgent. It is hereby ordered that the application to be served on respondent.

Two, that consideration, the urgency of the matter, I order stay of execution of ruling of **honorable Christine Wekesa** and all consequential orders there-to pending the hearing and determination of application interparties. The inter-party hearing is on 6th October 2022. Given under my hand and seal of the court at Marsabit, this 30th September 2022, issued at Marsabit this 3rd day of October 2022.
