### LEADERSHIP OF THE MINORITY PARTY

Honorable Members, you will recall that we were in Court on the issue of Minority Leadership in complaint *No. E008 of 2012* at the Political Parties Dispute Tribunal in Meru between Amos Guyo and Emojo Daniel versus UDA and Ford Kenya.

The Court gave its judgment on 11<sup>th</sup> November, 2022 and issued the following orders: *A declaration hereby issued that the entire process of nomination of the first interested party to the position of Minority in the County Assembly of Marsabit is null and void and the same is hereby set aside.* 

The respondents shall elect a Leader of Minority in accordance with the Standing Orders of the Marsabit County Assembly and all relevant provisions of law.

As such, we complied with the Court orders and wrote to UDA and Ford Kenya via MCA/SPK/GEN/01. We received one response from UDA via letter from the Secretary General referenced UDA/1/MCA/03/2022. This letter requested 21 days and when it elapsed, we wrote to them via MCA/SPK/GEN/02 on 4<sup>th</sup> January 2022 to inquire about the outcome of the internal dispute process.

We received their response via letter referenced UDA/1/MCA/04/2023 dated 09/01/2023. In the letter, the party indicated that they had resolved to nominate Hon Halkano Konso Ali as the leader of the Minority Party.

Honorable members, having received communication from the Minority Party, I wish to now communicate to the full House Leadership, for the avoidance of doubt. That in regard to the Majority Party/ Coalition:

The County Executive Committee of the County Government of Marsabit had their 72<sup>nd</sup> sitting on 13<sup>th</sup> December 2022 at the County headquarters and a proposal was tabled by H.E. the Governor to reorganize departments pursuant to Article 179 of the Constitution of Kenya,2010 and Sections 30,45 and 46 of the County Government Act No.17 of 2012 (Revised 2021). The same was deliberated upon and approved by the County Executive Committee in the manner enclosed in the Executive Order No.1 of 2022 by H.E the Governor, Mohamud Mohamed Ali. The purpose of this letter is therefore to notify you accordingly.

In exercise of the powers conferred by Article 179 of the Constitution of Kenya, 2010 as read with Section 30,45 and 46 of the County Government Act No.17 of 2012, I Mohamud Mohamed Ali, the Governor of Marsabit County Order and direct: that the County Government of Marsabit shall be organized as set out in this order; that the Chief Officers' portfolios shall be set out in this order; that this order supersedes any other executive order organizing the structure of the County Executive of Marsabit prior to this order issued under the hand and seal of the Governor of the County Government of Marsabit at the office of the Governor, Marsabit on 13th December 2022.
