THE MARSABIT COUNTY SUPPLEMENTARY APPROPRIATION BILL, 2018

A Bill for

AN ACT of the County Assembly of Marsabit to authorize the issue of certain sums of money out of the County revenue Fund and their application towards the service of the year ending on the '30th June, 2018, and to appropriate those sums for certain public services and purposes

ENACTED by the County Assembly of Marsabit, as follows-

1. This Act may be cited as the Marsabit County Supplementary Appropriation Act, 2018.

Short Title

2. The County Treasury may issue the sum of Kenya Shillings Seven billion, Seven hundred and thirty Million, Eight hundred and seventy five thousand, eight hundred and nine out of the County Revenue Fund and the year ending 30th their application towards the service of the year ending on June 2018 the 30th June, 2018 and that sum shall be deemed to have been appropriated as from the 1st of July, 2017, for the services and purposes specified in the schedule.

Issue of KSh 7,730,875,089 out of the County Revenue Account

3. In addition to the sum granted by section 2, the Appropriation of the sum specified in the fourth column of the First and Second Schedules shall be applied for the several services and purposes specified in the second column of those Schedules, out of revenue directed to be applied outside the County Revenue Fund under Article 206 (1) (b) of the constitution.
