
**NOTING THAT**, with the directives issued by the Speaker of the County Assembly, the Ad-Hoc committee was supposed to report back to the House with a comprehensive report after 30 days after it was constituted. **FURTHER NOTING**, the committee through the chairperson had to seek for an extension on the floor of the House with a progress

report for another 30 days on 13<sup>th</sup> March, 2024 to 24<sup>th</sup> April 2024 due to the heavy workload and waiting on responses from various county departments.

**ACKNOWLEDGING THAT**, the Committee has undertaken a tremendous amount of work in execution of its mandate; **CONCERNED THAT**, the committee has completed its finding but did not present its finding to the house which is a crucial component of its mandate. **APPRECIATING THAT**, the County Assembly has been granting the Committee extensions as requested notwithstanding the provisions of Standing Order 197 whereby the adhoc committee had its mandate on pending Bills through a motion approved by the House.

**NOW THEREFORE**, the County Assembly resolved to renew the mandate of the Ad Hoc Committee by a further period not exceeding 3 days with effect from **8<sup>th</sup> October 2024**, and to Table its final report on/or before **Wednesday, 10<sup>th</sup> October 2024**.
