

Nyamira turns into theatre of the absurd with two local assemblies

► The crisis stems from a failed attempt last year to impeach Governor Amos Nyaribo.

Nyamira County has descended into a political farce, with two parallel county assemblies operating simultaneously, leaving residents, stakeholders, and the national government bewildered.

The crisis stems from a failed attempt last year to impeach Governor Amos Nyaribo, which has fractured the assembly's leadership and governance.

Trouble began when 22 Members of the County Assembly (MCAs) voted to impeach Nyaribo, falling short of the required 23 votes by one, as 12 MCAs opposed the Motion.

Frustrated, the pro-impeachment MCAs accused Speaker Enock Okero of siding with the governor and moved to oust him. This sparked a schism, resulting in two rival factions, each claiming legitimacy and running county affairs independently.

Each faction has its own speaker and clerk. One, led by Okero, operates from the County Assembly headquarters, while the other, led by Ekereny MCA Thaddeus Nyabaro, holds sessions in venues gazetted as Bunge



Mashinani across the county.

For five months, this standoff has deepened confusion and disrupted governance.

On Tuesday, both factions appeared before the Senate, which, unsuccessfully, attempted to mediate. Kisii Senator Richard Onyonka emphasized the need for a political solution, urging the groups to reconcile

for the county's sake.

"The Nyamira County Assembly faces a political problem that requires dialogue to resolve," he said.

Governor Nyaribo, addressing the Senate County Public Accounts Committee, warned that the prolonged crisis might force him to request President William Ruto to appoint a special committee to manage the county or dissolve it entirely. Nyaribo accused Nyamira Senator Okongo Omogeni and some MCAs of fueling the divisions, despite his efforts to unite the factions. Nyaribo recognized Okero's faction as legitimate, citing court orders reinstating him, while dismissing Nyabaro's group as illegal.

Okero recounted his ousting to the Senate, explaining that his troubles began when the 22 MCAs who supported Nyaribo's impeachment accused him of bias.

In October last year, he was ejected from the assembly chambers during a session and later impeached in a process he claims was unfair and legally contested.

"The High Court's December 16 or-

der preserving my position as Speaker remains in effect," Okero said, noting that contempt proceedings against his rivals are ongoing, with a ruling expected on May 8.

Okero argued that his faction's decision to hold sessions outside the assembly precincts was lawful, as they had gazetted alternative venues for safety reasons. He insisted that Nyabaro's claim to the speakership, while serving as an MCA, violates court orders and constitutes contempt.

Nyabaro, however, defended his faction's actions, asserting that Okero's impeachment followed due process. He accused Okero's group, backed by Nyaribo, of illegally conducting assembly business outside the official Nyamira town precincts.

"Official duties are carried out where the county mace is, in Nyamira town," Nyabaro said.

The Senate expressed dismay at the spectacle. Nominated Senator Margaret Kamara called the situation embarrassing, noting that the factions' squabbles deprive residents of essential services.

"The people who elected these leaders deserve better," she said. Senator Peris Tobiko described the crisis as unprecedented, urging Nyamira's elected leaders to resolve it collectively.

Another blow to contractor of demolished 11-storey building

The contractor who executed the 11-storey building that was demolished on Wednesday in Mombasa has suffered a fresh blow after Governor Abdulswamad Nassir suspended the construction of 20 high-rise buildings they were working on.

Nassir, however, failed to name the contractor despite questions from the Press.

He said the contractor will solely be held liable for the death of one person, who was trapped in the rubble.

The governor said the contractor failed to use standardised steel and materials. He also did not name the buildings whose construction was suspended amid mounting questions about his adminis-

tration's earlier laxity to stop the project that claimed one life.

"We have suspended 20 building works under construction of the contractor behind the condemned building. All works by the said contractor have been and will be stopped, and once the preliminary report of the steel bars used comes out, we shall ensure they don't work anywhere in the country," said Nassir.

Nassir said experts spent four hours collecting samples of steel bars used on the pillars, and once the preliminary report comes out, action shall be taken against the contractor.

"We cannot allow our

emotions to take over and not hold people to account. Let us ensure people are safe first before we take action.

"We are rushing to see the steel bars used and if they meet the standard and quality mark. That is why we took four hours to take the samples," said Nassir.

The governor said he will ensure that the contractor's licence is revoked and he does not operate anywhere in the country.

The governor was reluctant to answer the set limit of floors allowed on the island for high-rise buildings. Mombasa's skyline is dotted with 15- and 16-storey buildings.
