7 STATEMENTS

Pursuant to Standing Order 41A of the County Assembly of Marsabit Standing Orders I give notice of the statement on subject matter above.

Hon. Speaker food distribution program plays a crucial role in supporting communities that have been affected by disasters. In the challenging times, food distribution initiatives become a lifeline, providing immediate relief to those affected.

To address the issue of food insecurity as a short-term plan, the County Assembly of Marsabit approved a budget of Kshs. 425 Million for drought mitigation program/Resilience building in the County Budget for the financial year 2023/2024. However, the use of the budgeted amount has not been accounted for hence, the utilization of the approved amount could not be determined.

In the spirit of the principles of public service delivery in the County as outlined by Section 116 of County Government Act, 2012, and Pursuant to Section 147 and 149 (1) of the Public Finance Management Act, 2012.

Accountability is a fundamental aspect especially when public funds is involved, therefore regular, reliable, and relevant information is expected in a timely manner.

To this end, I wish to inquire the following regarding the approved budget of Kshs. 425 Million for drought mitigation program/Resilience building:

- 1. How was the budgetary allocation to drought mitigation program/resilience building utilized?
- Could the CECM Administration and Public Service department to furnish the House with detailed lists of the contractors involved and the scope of work carried out and supporting documentations with regards to the aforementioned budget.
- 3. Provide distribution list of the same.

8 STATEMENT

Mr. Speaker, Pursuant to Standing Orders No. **41 (2) (C),** I seek for a Statement from the Chairperson of the Budget and Appropriation and Finance and Economic Planning Committee on the disposal of unserviceable vehicles and motor vehicles.

Mr. Speaker, the County Government of Marsabit recently advertised for the disposal of **76** unserviceable motor vehicles and motorcycles via tender document **no**. **MBT/COU/86/202-2-25** which closed on Monday 07th March, 2025.From the advertised list, some of them have been used for less than **10** years, and some are serviceable save for a few maintenance works.

This purported disposal might cost this County since some of the vehicles might be disposed of at a value way below their current values or some serviceable vehicles might be disposed of under the disguise of being unserviceable.

To this end I wish to inquire the following in regard to the disposable of unserviceable motor vehicles and motor cycles.

- 1. Are there an asset disposal committee established as provided for in Sec. 163 (1) of the Public Procurement and Disposal Act, 2015?
- 2. Whether the disposal procedure as provided in Sec. 164 (1-9) of the Public Procurement and Disposal Act, **2015** has been followed.
- 3. The department to provide a Mechanical Inspection report that rendered the targeted asset an Unserviceable.
- 4. The department to provide a Valuation report from a registered technical expert that set a reserve price for the assets earmarked for disposal.



5. The advertisement requires the bidders to pay a prescribed refundable deposit for any application. How did they arrive at the deposit amount for each asset? (provide criteria or any report being relied on)

6. The Amount being collected as a deposit was to be banked in a Bank account.

Can the department provide the Account used for this purpose? (Provide proof)
