7: STATEMENT

Mr. Speaker, Pursuant to Standing Orders No. 41 (2) (C), I seek for a Statement from the Chairperson of Administration, Coordination and ICT from the County Secretary and Head Public Service of County Government concerning financial governance and operational accountability of Marsabit County Government.

I rise before this Honourable House to bring to its attention matters of grave concern regarding the financial governance and operational accountability of Marsabit County Government.

Hon. Speaker, recent reports have highlighted potential inconsistencies within the County's payroll management system, including irregularities in personnel records and insufficient transparency in allocating funds for staff remuneration. Of equal concern is the lack of clarity surrounding the salary budget, which currently lacks detailed breakdowns to substantiate its allocations These issues warrant urgent scrutiny to uphold the principles of transparency, accountability, and prudent fiscal stewardship enshrined in our legislative mandate.

Hon. Speaker, this House has a solemn duty to ensure that public resources are utilized justly and in alignment with the interests of the citizens we serve. The people of Marsabit rightly expect their contributions to fund tangible services and genuine personnel, not unaccounted differences.

Hon. Speaker, this inquiry is critical to safeguarding public funds, restoring trust in Marsabit County's governance, and ensuring compliance with constitutional and statutory obligations, in the spirit of accountability to the people we represent.

In light of these concerns, I hereby move that this Honourable House directs all relevant departments of Marsabit County Government to submit, a comprehensive report containing the following:

- A complete register of personnel employed in each department, including full names, national identification numbers, designations, job groups, and assigned workstations.
- Detailed monthly remuneration statements for each employee, delineating base salaries, allowances, and additional benefits.
- Documentation of appointment dates, terms of service, and contractual agreements for all staff members.
- Verifiable attendance records and performance evaluations to confirm active service and compliance with duty schedules.
- Records of recruitment processes, including public advertisements, interview proceedings, selection criteria, and appointment approvals as per statutory regulations.

- A register of personnel currently on authorized leave, secondment, suspension, or undergoing disciplinary proceedings, with supporting documentation.
- Identification of individuals receiving remuneration without corresponding duty fulfillment, including explanations for such discrepancies and corrective actions taken.
