***6* MOTION: SOLID WASTE MANAGEMENT**

AWARE that under Part 2 of the Fourth Schedule to the Constitution of Kenya, refuse removal, refuse dumps and solid waste disposal are functions vested in county governments; **FURTHER AWARE** that the Environmental Management and Coordination Act (EMCA), 1999 (as amended), and the Sustainable Waste Management Act, provide the national framework for integrated solid waste management, which counties are required to domesticate and implement;

NOTING that Marsabit County continues to face severe challenges in solid waste management, particularly in urban and peri-urban centres, including inadequate capacity, weak coordination, illegal dumping, cartelism in waste handling, and general environmental and public health risks impacting households, businesses, and livestock;

CONCERNED that the absence of a dedicated institutional mechanism for coordinating solid waste management at the County level undermines efficiency, accountability, regulatory enforcement, environmental protection, and the overall quality of life for residents of Marsabit County;

DEEPLY CONCERNED that unmanaged solid waste now poses an emerging public health threat, environmental hazard, will affect sustainable urban development and expose the County to possible liability for the County, necessitating urgent structural and policy intervention;

NOW THEREFORE, this County Assembly urges the County Government of Marsabit, through the relevant County Executive Committee Member, to develop and table before the County Assembly a County Solid Waste Management Policy and Draft legislative proposal that proposes a governance structure that ensures representation from the municipal board, the Department of Environment and Lands, public health, NEMA, and the business community and borrows lessons and experiences from the management of solid waste management in the County since 2013.

Hon. Speaker, this Motion, if adopted, will go a long way in providing leadership and regulate the sector, restoring confidence among the population, improving well-being.

I therefore urge Honourable Members to support this Motion in the best interest of our people.
