Aware that, the Committee on Powers and Privileges, and procedure and rules, held its meeting on alleged breach of privilege and gross misconduct by Hon. Huka Galgallo and Hon. Jacob Elisha.

Further Aware that, in accordance to section 15(4) of the County Assemblies Powers and Privileges Act, 2017 which provides that a member shall be considered to have breached the powers and the privileges of the House if he or she conducts himself or herself in a manner which, in the opinion of the Committee on powers and privileges, and procedure and rules is intended, or is likely to reflect adversely on the dignity or integrity of the House, or of the Member or to be

contrary to the best interests of the House or its members or the member contravenes a provision of the national legislation providing for powers, privileges and immunities of County Assemblies, their committees and Members enacted by parliament pursuant to Article 193(3) of the Constitution of Kenya.

THEREFORE, that taking into consideration the findings of the Committee on powers and privileges, and procedure and rules in its report on inquiry into the alleged breach of privilege and gross misconduct by Hon.Huka Galgallo and Hon.Jacob Elisha Godana, laid on the table of the House on 07th April, 2026 pursuant to section 15(6) of the County Assemblies Powers and Privileges Act.
